- notify Treasury of any new GSF agencies, (note: under the GSF Act, an Accountable Authority has an obligation to notify the Treasurer and the Auditor-General of any new GSF agencies within one month after the entity becomes a GSF agency (refer s 2.8(1) of the GSF Act).
- notify Treasury of any GSF agencies abolished/dissolved, and
- provide any other updates (e.g. change of name, or status) in relation to GSF agencies in the list.

Treasury should be notified of any changes by emailing Legislation@treasury.nsw.gov.au.

Disclaimer: This list is intended as an **indicative guide** to the entities which are GSF agencies under the GSF Act. It is not intended to be a definitive list and the agencies should continue to have regard to the definition of 'GSF agency' used in the Act itself and obtain appropriate legal advice when in doubt.
